



Completion of this certification and/or declaration is required of tire dealers ("vendor") and haulers ("contractor") for the purpose of establishing mutual understandings in conducting business at the Hamilton County Tire Recovery Center located 7609 Standifer Gap Road in Chattanooga, Tennessee.

TERM OF DOCUMENT- This certification/designation shall be valid until notified otherwise by the vendor and/or hauler.

SUBMITTAL CERTIFICATION- Both the vendor and the hauler (signatories) certify, under penalty of law, they have personally examined and are familiar, to the best of their knowledge, with the information submitted on this form and with any necessary inquiry to those individuals immediately responsible for obtaining information. It is understood there are significant penalties for submitting false information, including the possibility of fine and/or imprisonment.

SAFETY- The Occupational Safety and Health Administration (OSHA) requires that employers protect their employees from workplace hazards that can cause injury. Personal protective equipment, commonly referred to as "PPE", is equipment worn to minimize exposure to a variety of hazards. The appropriate personal protective equipment is required during the unloading and loading process.

INDEMNIFICATION AND HOLD HARMLESS- Signatories on this document agree to indemnify, defend and hold harmless Hamilton County, members of its County Commission, boards, commissions and committees, officers, agents, employees and volunteers (hereinafter collectively referred to as "County") from any and all loss, damage, cost, expense, liability, claims, demands, suits, attorney's fees and judgments arising directly or indirectly from or in any manner related to the County's Tire Recovery Center. Signatories shall not be responsible when such liability arises from the sole negligence of the County. Signatories shall pay County for any costs incurred in enforcing this provision.

INSURANCE- Vendors and contractors are required to unload and lace-load their waste tires in the trailer designated by the Center Operator at their own risk. Signatories should maintain all applicable insurance coverages including, but not limited to, commercial general liability, business automobile, workers' compensation and employer's liability in accordance with applicable local, state and federal laws.
